Before me this date personally appeared MCCOY, SEAN (17192) who being first duly sworn deposes and says that on 30 day of March, (year) 2018 at 2200 SE 8TH ST, POMPANO BEACH, FL 33062 (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows:

On 3/30/18 at approximately 1800 hours I responded to 2200 SE 8th St in Pompano Beach, reference a fraud.
