At approximately 6:00 PM, Violent Crimes Detective Petrofsky and I were notified and responded to further investigate. At approximately 6:35 PM, I arrived at the hospital and met with Doctor Stringefellow suffered a left fractured rib, fractured sternum and pulmanery was on a ventilater, unresponsive and in critical condition. bruising. At approximately 6:50 PM, I arrived at the Broward Main Jail (555 SE 1st Avenue, Ft. Lauderdale) where I met with BSO Sqt. Williams who explained that there was a surveillance camera directly in front of cell 3 that captured the incident. With his assistance, I reviewed the surveillance footage of the incident. On December 16, 2023, at approximately 4:21 PM, I observed inmate Barnes walking in cell 3. He then walked off to the left side where the toilet is positioned and out of view of the cameras. I did for the next several minutes. At approximately 4:24 PM, not observe Barnes nor I observed Barnes choke holding from behind. Barnes held from behind in this position. Barnes is observed kneeling down still in the same position with only his head in view. Barnes remained in this position for approximately two minutes until approximately 4:26 PM, at which point Barnes let him go and walked away. Barnes paced around the cell for the next ten minutes. During this time, at no point did I observe on video. At approximately 4:36 PM, I observed Barnes walk to the front door and make a stomp like maneauver with his feet toward the ground where he had Greffard in the choke hold position. Barnes continued to pace around his cell for the next several minutes. At approximately 4:43 PM, I observed BSO Deputy Hernandez walking up the stairs * * * Continued * * * I swear the above statement is correct and true to the best of my knowledge and belief

He then walked to the front door and lookded downward inside the cell. The door to cell 3 opened and Deputy Hernandez located laying on the the floor against the wall. Additional personel arrived, including nurses, and they began . At approximately 5:17 PM, he was transported to resusitation efforts on Broward General Hospital byFort Lauderdale Fire Rescue. It should be noted at no point did Barnes attempt to notify deputies of the victim's condition or attempt to get the victim medical assistance in the almost 20 minutes that elapsed after he choked the victim. At approximately 8:00 PM, I met with offender Barnes at the jail for an interview. I read Barnes his Miranda Rights and I asked him if he understood them. Barnes stated that he did understand his rights. I repeated to him that he did not have to speak to me if he did not want to. He again stated that he understood. I then asked him if he wanted to tell me what happened. Post-Miranda, in summary, Barnes stated that he was cell mates . Barnes explained that he did not agree with because he was "gay" and that upset him. Barnes explained that kicked him first and then Barnes struck him with his closed fists. Barnes admitted that he placed him in a choke hold and later kicked him to see if he was alive. Barnes ackowledged what a choke hold maneuver is and what it can do. Barnes explained that it stops one from breathing. During our conversation, Barnes stated that he was upset at he smelled and never cleaned himself. Barnes admitted that he woke up from his sleep this afternoon and began insulting him and telling him that he needed to clean up and brush his teeth. The then got upset and stood up. Barnes stated he then "turned up", meaning he struck and beat Barnes stated that while he was choking and he realized he may and could take his life.
